Online Privacy Policy - Introduction

This document sets out the Rathfarnham Concert Band Society's Privacy Policy for this site. If you have any objections to this policy, you should not access or use this site. Rathfarnham Concert Band Society respects your right to privacy in relation to your interactions with this website. Any information which is provided by you will be treated in accordance with the terms of the Data Protection (Amendment) Act 2003 with regard to the processing of personal data.

Individual Rights

Outlined below is our policy on key privacy issues as they relate to this site. In every case, we will let you know what we intend doing with that information before collecting it, so that you can decide whether or not to furnish that information to us. If at any time after giving us this information you decide that you no longer wish us to hold or use this information, or in the case that the information becomes out of date, you are free to notify us, and we will remove or rectify the information within a reasonable time. Please note that this policy statement applies only to this Web site and is not intended to reflect the policy of any outside sites linking to or from www.rathfarnhamconcertband.com as well as www.rcbs.ie. If, at any time, you wish to contact us or have a question, you can reach us at the above website.

Collection and use of personal information

The Rathfarnham Concert Band Society does not collect any personal data about you on this website, apart from information which you volunteer (for example by e-mailing us, by using our online feedback form). Any information which you provide in this way is not made available to any third parties, and is used solely by the Society in line with the purpose for which you provided it. You acknowledge and agree that in certain circumstances we may be obliged to disclose personal information relating to you to third parties, for example, in order to conform to any requirements of law or to comply with any legal process, as well as to protect and defend the rights of property of RATHFARNHAM CONCERT BAND SOCIETY.

Collection and use of technical information

This website does not use cookies, apart from temporary "session" cookies which enable a visitor's web browser to remember which pages on this website have already been visited. Visitors can use this website with no loss of functionality if cookies are disabled from the web browser. Technical details in connection with visits to this website are logged by our internet service provider for our statistical purposes. No information is collected that could be used by us to identify website visitors. The technical details logged are confined to the following items:

- The IP address of the visitor's web server
- The top-level domain name used (for example .ie, .com, .org, .net)
- The previous website address from which the visitor reached us, including any search terms used
- Clickstream data which shows the traffic of visitors around this web site (for example pages accessed and documents downloaded)
- The type of web browser used by the website visitor.

The Rathfarnham Concert Band Society will make no attempt to identify individual visitors, or to associate the technical details listed above with any individual. It is the policy of the Society never to disclose such technical information in respect of individual website visitors to any third party (apart from our internet service provider, which records such data on our behalf and which is bound by confidentiality provisions in this regard), unless obliged to disclose such information by law. The technical information will be used only by the Rathfarnham Concert Band Society, and only for statistical and other administrative purposes. You should note that technical details, which we cannot associate with any identifiable individual, do not constitute "personal data" for the purposes of the Data Protection Acts, 1988 – 2003.
